

2012 Cougar Capers Talent Show

Information Sheet

Attention Cougars! It is time to "get your act together" for the 2012 Cougar Capers Talent Show to be performed at FIS on Friday evening, March 2nd at 6:30 pm. Singers, dancers, pianists, instrumentalists, gymnasts, jugglers, etc. are invited to audition for our awesome show sponsored by the FIS Cougar Chorale. Please read the following rules and begin working on your act NOW! Applications are due NO LATER THAN Wednesday, January 25th, 2012.

RULES:

1. All participants in an act must be Fayetteville Intermediate students. (Exception: an accompanist for a solo singer or instrumentalist need not be a FIS student).
2. Acts are limited to 5 minutes. Please be original and creative when selecting a song to sing or dance to. You want your act to stand out and if you choose the most current/popular hit song, there are apt to be many others doing the same.
3. No lip-sync or air guitar. Singers must have an accompanist or an accompaniment track—they may not sing with a CD containing the lead vocals.
4. All acts and costumes must be appropriate for school presentation. Our committee reserves the right to deny any act's participation in the Talent Show. No vulgar costumes, expletives, or inappropriate material will be permitted.
5. The only equipment available to you is the school sound system (2 microphones, 2 microphone stands and a monitor), a piano, music stands, and tape or CD playback.
6. All acts will be auditioned **in costume** before our talent show committee in the music room on the afternoons of Monday, February 6th or Thursday, February 9th and are to be "performance ready." Please do not come with only a portion of your act prepared. This will give the judges the most accurate representation of what will take place at the talent show.
7. Applications are due to Ms. Owens NO LATER THAN January 25th at 12 pm. If you are participating in a group act, EVERY PERSON IN THE GROUP must submit an application. Only those students who have turned in an audition form will be assigned an audition time.
8. The decision of the judges is final. No appeals will be allowed.
9. **All** participants must be able to attend the dress rehearsal on Thursday, March 1st from **2:30-4:30 PM** in the cafeteria.
10. The show will be held on Friday evening, March 2nd at 6:30 PM. You must report to the music room in costume by 6:00PM.

Again, pick up an application from Ms. Owens.

They are due to Ms. Owens NO LATER THAN Wednesday, January 25th at 12 pm.
